Dispute Resolution Clause. When negotiating a dispute resolution clause in a contract, the parties should consider whether litigation, arbitration or some other alternative dispute resolution forum is appropriate. If the parties decide on litigation, then the dispute resolution clause should define both the applicable court and law.

Arbitration, a form of alternative dispute resolution (ADR), is a way to resolve disputes outside the

courts. The dispute will be decided by one or more persons (the "arbitrators", "arbiters" or "arbitral tribunal"), which renders the "arbitration award". An arbitration award is legally binding on both sides and enforceable in the courts.
